Post your E-rate Form 470 Description of Services Requested and Certification Form early so that you are ready for the spring Funding Year 20 Application Filing Window. The date for the filing window has not been issued yet by USAC (Universal Service Administrative Co.).

Participants saw popular hacking tools in action and gained experience defending critical data. Utilizing an environment that models many enterprise networks, participants learned how environments get compromised, how breaches get discovered, and how to respond most effectively with Cisco Security products and integrated solution architectures.

CEN Forum - Protecting Our Communities from Ransomware Attacks November 19, 2019 CCSU, New Britain, CT

Thank you to the presenters and participants of our forum on ransomware protection, which took place in November. News stories are plentiful of cities and towns paying tens of thousands of dollars to ransomware hackers to get their data back, and this does not include the millions



spent in cleanup and in rebuilding a network following an attack. Ransomware attacks are perhaps the greatest current threat to our members' networks, private data, operational continuity, and financial health.

CEN community members, security experts, and homeland security representatives took part in this important CEN Forum - Protecting Our Communities from Ransomware Attacks on November 19 at Central Connecticut State University.

Participants in this forum learned more about:

- What are the current threats, and how are they recognized?
- What steps can be taken now to protect your organization's data and infrastructure?
- How can you create and sustain end-user education to strengthen the weakest link?
- What will this cost, and how can you justify it?
